Sustainable Investment Approach for Treasury Positions of Raiffeisenlandesbank Niederösterreich-Wien AG

Raiffeisenlandesbank Niederösterreich-Wien AG (RLB NÖ-W) pursues a comprehensive sustainable investment approach within its Treasury function, systematically integrating ESG criteria into all investment decisions. The objective is to combine financial stability with social responsibility and to make an active contribution to sustainable development.

Strategic Orientation

The sustainable investment approach in RLB NÖ-W's Treasury is based on a combination of a passive and an active strategy.

- **Active Strategy**

RLB NÖ-W aims to allocate an increasing share of its new investments specifically to sustainable bonds (ICMA-compliant), such as Green Bonds, Social Bonds, or Sustainability Bonds. By 2030, the share of sustainable investments in Treasury is to increase to 30% of the total Treasury portfolio.

- **Passive Strategy**

By applying clearly defined ESG criteria, it is ensured that no investments are made in companies or sovereigns that violate environmental, social, or governance standards. The ESG Criteria include an assessment of:

- the **ESG rating** of the issuer (see ESG integration and selection process), as well as
- **positive and negative criteria** and **sector exclusion criteria** in line with the Sustainable Positioning as part of RLB NÖ-W's overall business strategy.

Issuers operating in controversial sectors or whose business models have significant negative impacts on the environment or society, or who strictly do not meet RLB NÖ-W's ESG rating requirements are excluded from investment.

ESG Integration and Selection Process

Investment selection is therefore based not only on RLB NÖ-W's sustainable positioning but also on ESG ratings provided by leading ESG rating agencies.

- **MSCI ESG Rating**

Investments are made exclusively in issuers with ratings ranging from AAA to a maximum of BB.

- **Sustainalytics ESG Risk Score**

Only issuers with an ESG Risk Score of no more than 30 are considered.

If there is no ESG rating is available for an issuer, alternative sources of information are used, such as ESG frameworks prepared by external providers for the respective issuer or Second Party Opinions. The final investment decision is always made considering all available sustainability-related information.

Continuous Monitoring and Divestment

Following an investment, all issuers are subject to ongoing monitoring. If an issuer's sustainability profile or the regulatory framework deteriorates materially, divestment is reviewed and implemented where appropriate. This ensures that the portfolio continues to meet RLB NÖ-W's sustainability standards over the long term.

Engagement Policy and Handling of Breaches

As part of ongoing monitoring, all investments are regularly reviewed for compliance with the defined ESG criteria. If it is determined that an issuer violates the established sustainability standards or regulatory requirements, or if its sustainability profile deteriorates significantly, this is addressed within the relevant internal committees.

RLB NÖ-W subsequently engages in an active dialogue with the issuers in which it is invested in order to promote compliance with and further development of sustainability standards, considering the accessibility of the respective issuers. Any dialogue conducted is documented and taken into consideration in the final decision-making process.

The decision on a potential sale or retention of a position is made with due consideration of regulatory minimum holding periods and the risk/return profile with regard to profit and loss and is documented transparently.

Integration into Risk Management and Governance

Sustainability is an integral component of the investment process and risk management framework. All investments are subject to a standardized review and

decision-making process, which is discussed and approved by the relevant internal committees. RLB NÖ-W's ESG strategy and thus its sustainable investment approach, is closely aligned with EU regulatory requirements such as the EU Taxonomy and SFDR, as well as international standards such as ICMA and the UN Global Compact.

Transparency and Continuous Development

RLB NÖ-W places a strong emphasis on transparency and the continuous development of its sustainable investment approach. The applied criteria, processes, and targets are reviewed regularly and adapted to new regulatory requirements and market developments.

The bonds are all traded in EUR, the green marked Bonds are the Green Bonds. As of 31 December 2025, the current bond positions in the banking book of RLB NÖ-W amount to a nominal volume of EUR 5.6 billion (31 December 2024: EUR 5.5 billion). Of this amount, bonds with a nominal volume of EUR 0.9 billion (31 December 2024: EUR 0.7 billion) comply with ICMA standards and are therefore classified as ESG-compliant or green, representing a relative share of 15.8% (31 December 2024: 14%).
