This supplement (the "**Supplement**") dated 30 March 2026 constitutes a supplement pursuant to Article 23 (1) of the Regulation (EU) 2017/1129, as amended (the "**Prospectus Regulation**") and is supplemental to, and should be read in conjunction with, the base prospectus dated 5 June 2025 (the "**Original Prospectus**") and together with Prospectus Supplement No. 1 dated 1 September 2025 for the Debt Issuance Programme (unlimited in size) (the "**Programme**") of Raiffeisenlandesbank Oberösterreich Aktiengesellschaft ("**RLB OÖ**" or the "**Issuer**"). The Prospectus forms the base prospectus of the Issuer within the meaning of Article 8 (6) of the Prospectus Regulation.

The Original Prospectus has been approved on 5 June 2025 by the Austrian Financial Market Authority (*Finanzmarktaufsichtsbehörde*, the "**FMA**").

This Supplement has been filed with and approved by the FMA in its capacity as competent authority, filed with the Vienna Stock Exchange (*Wiener Börse*) and published in electronic form on the Issuer's website under "www.raiffeisen.at/ooe/rlb/de/meine-bank/investor-relations/eigene-emissionen/prospekte-und-bedingungen.html".

Terms defined in the Prospectus shall have the same meaning when used in this Supplement.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference in the Prospectus by this Supplement and (b) any other statement in or incorporated by reference in the Prospectus, the statements mentioned in (a) above will prevail.

Save as disclosed in this Supplement, no other significant new factor, material mistake or material inaccuracy relating to the information included in the Prospectus has arisen or been noted, as the case may be, since the publication of the Prospectus.

In accordance with Article 23 (2) of the Prospectus Regulation, investors who have already agreed to purchase or subscribe for securities issued or to be issued by the Issuer before this Supplement was published have the right, exercisable within three working days after the publication of this Supplement, to withdraw their acceptances until, and including 2 April 2026, provided that the significant new factor, material mistake or material inaccuracy arose or was noted before the closing of the offer period and the delivery of the Notes, whichever occurs first. Investors may contact the relevant financial intermediary if they wish to exercise their right of withdrawal.

The accuracy of the information contained in this Supplement does not fall within the scope of examination by the FMA under the Prospectus Regulation. The FMA only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer that is the subject of this Supplement.

"In the 2025 fiscal year, there was a reversal of the RBI group's impairment loss in the amount of EUR 44.3 million (2024: EUR -10.7 million), resulting in an IFRS carrying amount of EUR 1.2 billion as of 31 December 2025 (31 December 2024: EUR 949.2 million)."

In the section entitled **"RISK FACTORS – RISK FACTORS REGARDING RLB OÖ - Risk factors regarding RLB OÖ Group's business operations - Investment Portfolio Risk"** in the risk factor entitled **"The Issuer may bear the risk of value losses of its investment portfolio (investment portfolio risk)."** commencing on page 4 of the Original Prospectus, the second paragraph under the subheading **"Participation risk relating to voestalpine AG"** shall be replaced by the following paragraph:

"No significant recovery is expected for the construction, mechanical engineering, consumer goods and automotive sectors. With an operating result (EBITDA) in the range of EUR 1.4 to EUR 1.55 billion, the earnings outlook for the 2025/26 financial year is slightly above the previous year's figure of EUR 1.35 billion."

"Mag. (FH) Isabella Pohl association auditor of and appointed by "Österreichischer Raiffeisenverband", Friedrich-Wilhelm-Raiffeisenplatz 1, 1020 Vienna, Austria performed the statutory audit of RLB OÖ's German language version consolidated and unconsolidated financial statements for the fiscal years ending on 31 December 2024 and 2025 and issued an unqualified opinion in each case. "Österreichischer Raiffeisenverband" is a member of "Vereinigung Österreichischer Revisionsverbände".

In addition, RLB OÖ has appointed KPMG Austria GmbH, Wirtschaftsprüfungs- und Steuerberatungsgesellschaft (a member of "Kammer der Steuerberater:innen und Wirtschaftsprüfer:innen"), Kudlichstraße 41, 4020 Linz, Austria as voluntary auditor, which has performed an additional audit of RLB OÖ's German language version consolidated and unconsolidated financial statements for the fiscal years ending on 31 December 2024 and 2025, the respective unqualified audit reports (*Vermerk*) are dated 1 April 2025 and 17 March 2026."
